**SECTION 4 : FIRST AID MEASURES**

**4.1. Description of first aid measures In****the event of exposure by inhalation :**

If the person is unconscious, place in recovery position. Notify a doctor in all events, to ascertain whether observation and supportive hospital care will be necessary.

**In the event of splashes or contact with eyes :**

Wash thoroughly with soft, clean water for 15 minutes holding the eyelids open. Regardless of the initial state, refer the patient to an ophthalmologist and show him the label.

**In the event of splashes or contact with skin :**

Remove any soiled or splashed clothing immediately. Watch out for any remaining product between skin and clothing, watches, shoes, etc. If the contaminated area is widespread and/or there is damage to the skin, a doctor must be consulted or the patient transferred to hospital.

**In the event of swallowing :**

Seek medical attention, showing the label.
